## RESPONDING TO THE UNITED STATES FEDERAL GOVERNMENT'S ATTACK ON IMMIGRANTS, MIGRANTS, AND REFUGEES

## (Sense of the assembly)

## Summary

 This emergency resolution denounces the United States federal government's mass detention and deportation campaign, as well as the egregious human rights violations being committed against those who are being detained and deported. It also denounces the government's disregard of the civil and human rights of immigrants, migrants, and refugees, as demonstrated through the current Administration's attacks on humanitarian protection and due process, ongoing funding freezes, and the infringement on the religious rights of houses of worship to welcome and provide charity services to all people, regardless of their citizenship status. It calls on all settings of the Christian Church (Disciples of Christ) in the United States and Canada, including General Ministries, Regions, and local congregations to provide additional support for Immigrant Welcoming and sanctuary congregations, and calls for prophetic action in solidarity with immigrants, migrants, and refugees in light of the current increase in anti-immigrant policies being implemented by the federal government.

## Biblical, Theological, and Historical Grounding

As Christians, we believe that all people, including immigrants, are made in the image of God. This is demonstrated throughout the Bible, including in Leviticus 19:33-34 ("When an immigrant resides with you in your land, you shall not oppress the immigrant. The immigrant who resides with you shall be to you as the citizen among you; you shall love the immigrant as yourself, for you were immigrants in the land of Egypt;"), Matthew 25:35 ("for I was hungry and you gave me food, I was thirsty and you gave me something to drink, I was a stranger and you welcomed me,...") and Mark 12:31 ("... 'You shall love your neighbor as yourself.' There is no other commandment greater than these."). Yet the federal government's policies on immigration fail to respect the Godgiven dignity of every person and our call to welcome the stranger.

 **WHEREAS** on January 29, 2025, President Trump signed an executive order to expand immigration detention in Guantanamo Bay Prison Camp. Detainees were not given a

40 trial before being transferred to the Prison Camp. Administration officials have not

offered evidence to support their claim that those moved to Guantanamo are gang members, and most of the immigrants whose identities have become public did not have criminal records<sup>1</sup>; and

**WHEREAS** on January 29, 2025, President Trump signed into law the Laken Riley Act, which applies mandatory immigration detention solely on the basis of an arrest or charge for a theft-related offense, without any opportunity to even request release on bond, risking the detention of people innocent of the charges brought against them. Prolonged detention without access to an individualized bail or bond hearing denies the accused their day in court – a constitutional right<sup>2</sup>; and

WHEREAS on March 15, 2025, the current administration invoked the Alien Enemies Act of 1798, a wartime law that was used to authorize the forcible internment of people of Japanese descent during World War II, to authorize the deportation of Venezuelan immigrants to mega prisons abroad. This law gives the President authority to remove nationals of a country that the U.S. is at war with, and the U.S. is not at war with Venezuela. These nationals were not given access to a trial, a right to appeal, or time to notify their families, in violation of the constitutional right to due process<sup>3</sup>; and

 **WHEREAS** there have been multiple reports of green card visa holders with no criminal records being detained or deported by Immigration and Customs Enforcement (ICE)<sup>4</sup>, and in some cases, ICE has detained and sought to deport valid visa holders who participated in public protests<sup>5</sup>; and

**WHEREAS** the Trump Administration has deported U.S. citizen children of undocumented immigrants, and detained indigenous people with U.S. citizenship<sup>6</sup>; and

**WHEREAS** the Trump Administration is contracting with private prisons to house detained immigrants. Government inspections for years have found evidence of negligence at private detention facilities, from a lack of access to medical care to unsanitary conditions, including problems that may have led to deaths of detainees. Lawsuits against the companies allege that programs paying detainees as little as \$1 a day to work is tantamount to illegal forced labor<sup>7</sup>; and

**WHEREAS** since January 20, 2025, the current administration has passed additional policies that violate the basic rights of immigrants, including:

Suspending all border entries, including asylum-seekers, effectively ending asylum at the US-Mexico border, as well as revoking the legal status of immigrants previously protected by humanitarian parole programs, such as Ukrainians, Afghans, and the Cubans, Haitians, Nicaraguan, and Venezuelan (CHNV) program<sup>8</sup>;

\* Suspending the US Refugee Resettlement Program and freezing funding related to the Program<sup>9</sup>;

 Reinstating the "Remain in Mexico" policy, which forces asylum seekers to wait in Mexico while their cases are processed<sup>10</sup>;

Attempting to deny birthright citizenship to certain immigrant children<sup>11</sup>;

Restarting the detention of migrant families<sup>12</sup>; 88 Rescinding the Sensitive Locations Guidance, allowing ICE to conduct 89 raids in schools, hospitals, and places of worship<sup>13</sup>; and 90 WHEREAS some elected officials in the United States have chosen to portray 91 92 immigrants as criminals, yet immigrants are statistically less likely to commit crimes than people born in the U.S., immigrants have had lower incarceration rates than native-born 93 Americans for at least 150 years, and undocumented immigrants have lower felony 94 arrest rates than legal immigrants or native-born Americans<sup>14</sup>; and 95 96 97 **WHEREAS** the current actions of the government against refugees, visa-holders, asylum seekers, and undocumented people leads many of these communities to 98 99 remove themselves from public life, including attending church and being involved in their church community<sup>15</sup>; and 100 101 102 WHEREAS our Christian tradition affirms the belief that all people are made in God's 103 image, including immigrants, migrants, and refugees, in accordance with the biblical 104 teachings of Leviticus 19:33-34, Matthew 25:35, and Mark 12:31; and 105 106 WHEREAS the General Assembly meeting in Indianapolis, IN in 2017 passed the resolution GA1722 "On Becoming Immigrant Welcoming Congregations," which 107 108 declared that congregations, ministries, organizations, and institutions of the Christian 109 Church (Disciples of Christ) will continue to strive to respect and affirm the dignity of 110 every child of God and to advocate for the fair and just treatment of immigrants and 111 immigrant families in the United States and Canada.; 112 113 **THEREFORE BE IT RESOLVED** that the 2025 General Assembly of the Christian 114 Church (Disciples of Christ) in the United States and Canada, meeting July 12-15, 2025, 115 in Memphis, Tennessee affirms that all those made in God's image should be afforded 116 basic human rights, including the constitutional right to due process.

BE IT FURTHER RESOLVED that the 2025 General Assembly, meeting July 12-15, 2025,in Memphis, Tennessee denounces all attempts by the federal government to violate the basic human rights of immigrants, migrants, and refugees.

**BE IT FURTHER RESOLVED** that the 2025 General Assembly, meeting July 12-15, 2025, in Memphis, Tennessee affirms that the federal government's actions towards immigrants, migrants, and refugees stand in violation of the Alien Enemies Act of 1798, the U.S. Constitution, and the 1951 Refugee Convention.

**BE IT FURTHER RESOLVED** that the 2025 General Assembly, meeting July 12-15, 2025, in Memphis, Tennessee denounces all violations of the constitution, federal law, and international human rights law committed by the current administration, including its abuse and misuse of the Alien Enemies Act, its denial of the constitutional right to due process for immigrants summarily deported or indefinitely detained, and its ending of the asylum seeker and refugee resettlement programs.

**BE IT FURTHER RESOLVED** that the 2025 General Assembly, meeting July 12-15, 2025, in Memphis, Tennessee calls on the General Ministries, Regions, and local congregations to reaffirm their commitment to protect, advocate for, and serve our immigrant, migrant, and refugee neighbors during a time of heightened anti-immigrant sentiment and xenophobia.

**BE IT FURTHER RESOLVED** that the 2025 General Assembly, meeting July 12-15, 2025, in Memphis, Tennessee calls on the General Ministries, Regions, and local congregations to speak prophetically in the public square regarding our call to love our neighbor and welcome the immigrant, whether that be through the context of public witness, public statements, legislative advocacy, legal action, ecumenical partnerships, or direct service.

**BE IT FURTHER RESOLVED** that the 2025 General Assembly, meeting July 12-15, 2025, in Memphis, Tennessee affirms the religious and constitutional rights of all Immigrant Welcoming and sanctuary congregations and all clergy to continue to welcome and serve immigrants, even as they face extreme threat by the federal government, as well as certain state and local governments, putting at risk the safety of their place of worship, their financial stability, and their very existence during a time of heightened xenophobia and anti-immigrant sentiment.

**BE IT FINALLY RESOLVED** that the 2025 General Assembly, meeting July 12-15, 2025, in Memphis, Tennessee calls on the General Ministries, Regions, and local congregations to increase capacity and resources to support and advocate for
